All appointments or directives made by the Chair shall be approved by simple majority vote of the State Central Committee and may be amended or repealed by a majority vote of the State Central Committee. The maximum term of any committee appointment shall be no longer than the term of the committee which made the appointment. Appointees may be eligible for reappointment via a simple majority vote of the new State Central Committee upon start of the new cycle. Service contracts, such as the Executive Director contract, shall be honored per terms of contract."
